1: Voluntary Application. I, the undersigned, acknowledge and state that I have voluntarily applied to compete in the 2018 IKF Semi-Contact KickBoxing -Kuro Bushi Championship Tournament June 2, 2018.

2: Assumption of risk. I am aware & understand that in general, Semi contact fighting is a dangerous & hazardous activity, & in particular, the techniques & methods of this convention, all in which as a competitor in this competition, I shall be participating, is an extremely dangerous & hazardous event. I am voluntarily & of my own free will submitting an application to compete in this event with full knowledge & understanding of the hazards involved. I hereby consent & agree to completely accept alone any & all risks of injury or death, & I verify & confirm this statement by placing my initials here:

3: Release: In consideration for (a) being accepted as a competitor of AK Promotions & The International Kickboxing Federation and the Tournament Promoter/Director: Ernest Dukes kuro Bushi Martial Arts Organization (b) being entitled to participate in activities conducted and sanctioned by the IKF (International Kickboxing Federation and (c) being permitted to use facilities and equipment, whether owned or leased by AK Promotions and/or The IKF and all associates, officials, employees, staff, and fellow participants and trainers/coaches.
